What investment services and advice can you provide me?

We are a registered investment adviser that offers investment advisory services, including Asset Management, Comprehensive Portfolio Management, and Financial Planning & Consulting, to clients. If you open an advisory account with our firm, we’ll meet with you to understand your current financial situation, existing resources, objectives, and risk tolerance. Based on what we learn, we’ll recommend a portfolio of investments that is reviewed at least annually with you. Our investment committee meets monthly to review our overall portfolio and investment strategies. If necessary, we will rebalance your accounts to meet your changing needs and goals. We will offer you advice on a regular basis and contact you at least annually to discuss your portfolio.

We manage advisory accounts on a discretionary or non-discretionary basis, as agreed with you in accordance with an executed investment advisory client agreement. For discretionary accounts, we will implement transactions without seeking your prior consent. For non-discretionary accounts, we will seek your prior consent for every contemplated transaction. Limitations may be imposed by you in the form of specific constraints on any of these areas of discretion with our written acknowledgement.

We do not restrict our advice to limited types of products or investments. Our firm does not impose requirements for opening and maintaining accounts or otherwise engaging us.

What fees will I pay?

You will be charged an ongoing annual fee applied quarterly based on the value of the assets in your account. Our maximum Comprehensive Portfolio Management and Asset Management annual fee is 1.50%. The more assets you have in your advisory account, the more you will pay us. We therefore have an incentive to increase the assets in your advisory account in order to increase our fees. Our fees vary and are negotiable. The amount you pay will depend, for example, on the services you receive and the amount of assets in your account. Our firm’s fees will be automatically deducted from your advisory account, which will reduce the value of your advisory account.

Our maximum flat fee is \$30,000 for our Financial Planning & Consulting service. We can charge a planning fee when you sign an agreement for this service or charge you when we deliver a financial plan or consultation.
